NOTIFICATION FOR INTENDED FILMING

May 4th, 2009

Dear Neighbors,

We are proposing to film scenes for our feature film "Rasputin" on Wednesday, May 6th from 4:00 PM to 11:59 PM (MIDNIGHT) at:

- **805 W. Manchester Blvd. (Randy's Donuts)**

Our planned activity is to film interior & exterior walk & talk dialogue with actors sitting/standing in the actual big donut. We plan to have picture cars in the parking lot (*mostly static, some moving on property only*), atmospheric smoke effects, actor's smoking cigarettes, wet down, ***RITTER FANS for WIND effects*** and intermittent traffic/pedestrian control for safety & sound.

PREP: 5/5 from 7AM-10PM – interior & exterior set dressing as well as rigging the big donut to have actors standing or sitting in it.

STRIKE: 5/6 from 7AM-10PM – reverse of prep, clean up location.

BASE CAMP/CREW PARKING: 1030 W. Manchester (parking lot – **ARRIVING 5AM**)

Proposed **CURB LANE CLOSURES:** 5/6 from 4PM-MIDNIGHT on the:

- **NORTH side of W. Manchester Blvd. from La Cienega Blvd. to Glasgow Ave.**
- **WEST Side of La Cienega Blvd. from W. Manchester going North for 400'**

Proposed posted "**NO PARKING**" on 5/6 from 7AM-MIDNIGHT on the:

- **NORTH side of W. Manchester Blvd. from La Cienega Blvd. to w. Glasgow Ave (meter #s: 800, 801, 802, 803, 804, 805 & 806)**
- **EAST Side of S. Glasgow Ave. from W. Florence Ave. going South to Manchester Blvd. (meter #s: 111, 112, 113, 114, 115, 116, 117, 118, 119, 120, 121 & 122)**

Proposed posted "**NO PARKING**" on 5/5 & 5/6 from 5AM-MIDNIGHT on the:

- **BOTH sides of Hindry Ave from W. Manchester Blvd –going South 300' (meter #s: 302, 303, 304 & 305 on the WEST side AND 533, 532, 531, 530 on the EAST side)**

We understand the impact that filming can have on a neighborhood and want to assure you that we will work hard to minimize our presence by demonstrating extreme care and consideration while we are your guests. We have applied for the necessary permits and maintain all legally required liability insurance.
